Conference Call March 16, 2011

I. Roll Call:

Ken Knight, Jack McCabe, Jeff Reimer, Keith Pellemeier, Darla Mills, Richard Ibarra and Cindy McCall participated in the Conference Call.

II. Review and Amendments to the Agenda:

III. Update on Committees:

Website Committee:

Jeff extended apologies for delays on the website. Ken noted the positive comments received about the website from Delaware. The individuals found the website useful for youth education. Ken requested that the Co-Chair information be changed to reflect Richard Ibarra and Ken Knight. Jeff requested Richard send him personal information to meet this request. He stated he currently posts items as they are received to the website and would like assistance from someone to assist with filtering information prior to posting. Education Committee:

"San Luis Obispo Workshop"

Ken discussed Arbor Week that was set by California Releaf as March 7-14, 2011. Goleta Valley Beautiful held 7 events and took advantage of the promotional funding available through California Releaf. Lompoc's Arbor Day is March, 19, 2011, San Luis Obispo is April 9, 2011 and Simi Valley is May 7, 2011.

"Trail of Trees Program"

Jack stated that Tim Womack is an excellent presenter in children's education. "He is extremely professional." Tim visits California every year for the State Fair. Jack would like for us to look for resources to have Tim present in our region. Keith inquired on

Tim's place of residence with Jack responding North Carolina. Additionally, Keith suggested we try to host Tim for a week so he could attend multiple sites. Jack would like to see the state sponsor this program. Keith requested this item appear on an agenda later this year.

"Urban Forest Management Plan Presentations"
